## BOWLING GREEN TOWNSHIP BOARD OF TRUSTEES

Held March 26, 2013

Bowling Green Township Board of trustees opened this regular meeting at 7pm with roll call. Trustee VanBuren & Trustee Chorpenning were present. Trustee Hupp was absent.

**CORRESPONDANCE** Trustee Chorpenning: I CP department letter announcing April 22 Public hearing on amendment to subdivision regulations. FO: Email from Bill Lozier about Permissive Motor Vehicle Registration fees, add to agenda for next meeting.

Trustee Chorpenning had a correction to make on the minutes from January 29<sup>th</sup>. The amendments to the motion made about the merry go round were not included in the minutes.

### REPORTS

**SAFETY** Everything has been checked and is in good condition.

**ZONING INSPECTOR** Zoning Inspector received a call about property on Somerset RD. Property owner still needs to have a soil test done and sewer approved.

**PARK COMMITTEE** Barb Wiseman had a report. There were 4 rentals and a brick sale. New board member Mark Caudill. Need sand, cement and dirt fill for the hurricane spinner. Trustee Chorpenning said Chris Meyer from the playground company called and said they haven't been paid yet. FO said there is a check tonight to sign tonight for the amount of the grant. Barb also said they are having their Easter Egg hunt on Saturday at 10am. Bake sale 9-12.

**UNFINISHED BUSINESS** Trustee Hupp not present to give report on trash. Trustee Chorpenning has had more residents calling to complain about Big O not picking up recycling.

Trustees will discuss road bids next month.

Trustee Chorpenning made a motion to sign mileage certification with note to add cul de sac to Snaedden rd. Trustee VanBuren seconded the motion. Roll Call: Chorpenning yes, VanBuren yes, Hupp absent.

### PUBLIC COMMENT

Dennis Allison, resident of Dogwood, said he was originally told the recycling would be picked up on the 1<sup>st</sup> & 3<sup>rd</sup> Wednesday but the bill says weekly.

Jack Hedges would like to know why Barb Wiseman signed for the hurricane spinner when she isn't an officer or anything. Trustee Chorpenning says the money wasn't really tax payer money because it was grant money. Trustee VanBuren said he would sign the check using the grant money but he has a problem with the money in addition to the grant money. Trustee Chorpenning said the shipping and installation money came out of the park fund.

Trustee VanBuren made a motion to pay the bills; sign purchase orders and blanket certificates, and the bank statement. Trustee Chorpenning seconded the motion. Motion Carried. It is lawfully certified that the amount \$7,364.50 is lawfully appropriated to pay the bills by the fiscal officer.






